PRIVACY POLICY

What we need

Aberdeen Bon Accord MBC Hockey Club promote hockey in Aberdeen and the north-east of Scotland, catering for all ages, gender and abilities in the game of hockey.

We are associated regionally to Scottish Hockey North District and nationally to Scottish Hockey.

Aberdeen Bon Accord MBC Hockey Club will be a "controller" of the personal information that you provide to us through this website and in our membership form.

Option 1 – Members' personal data:

When you register as a member of BAMBC or renew your membership (including if you are registering or renewing on behalf of a child under the age of 18), we will ask you for the following personal information:

- contact details name, address, email address, date of birth, phone numbers;
- membership criteria / categoryfor

example, adult, under-18, youth, parent, volunteer;

- payment details bank account number, sort code, card details;
- participation details for example, parent, youth, volunteer;
- equality information for example, disability, gender; and
- any other personal information, for example, PVG membership, medical information.

Option 2 – Volunteers' personal data:

When you volunteer with BAMBC, we will ask you for the following personal information:

 contact details – name, address, email address, date of birth;

- participation details for example, parent, committee;
- equality information for example, disability; and
- insert any other personal information, for example, PVG membership.

Why we need your personal information – contractual purposes

Option 1 – Members' personal data:

We need to collect our members' personal information so that we can

manage your membership. We will use our members' personal information to:

- provide you with core member services, including insurance, licensing, voting;
- set up your online membership account for team management purposes;
- send you membership communications by post or email in relation to essential membership services, including but not limited to, general meeting notices, membership renewals, membership fees' information;
- If you do not provide us with all of the personal information that we need to collect then this may affect our ability to offer the above membership services and benefits.

Option 2 – Participants' personal data:

When you book a place with us for and attend a competition, event, training, we need to collect your personal information so

that we can honour your attendance and to enable you to participate in the competition, event.

If you do not provide us with all of the personal information that we need to collect, then this make affect our ability to honour your attendance.

Why we need your personal information – legitimate purposes

Option 1 – *Members' personal data:*

We also process our members' personal information in pursuit of our legitimate interests to:

- promote and encourage participation in hockey by sending members' communications and availability information for upcoming competitions and events. Our competitions and events may be filmed or photographed and your
- personal information may also be used in images captured from our competitions and events, which we use for promotional, education and development purposes;
- provide competition in hockey by accepting and managing entries for our competitions and checking your personal information to ensure you are entered into the correct category;
- monitor and develop participation in hockey by monitoring members' engagement and participation through research and inviting our members to participate in surveys for researching and development purposes;
- invite our members as award winners or guests to our annual awards dinner / ceremony, which includes asking our members to nominate individuals for awards and shortlisting such individuals to select the winners, who we will then

contact by email;

• develop and maintain our members' qualifications, including sending email communications to members to inform you of upcoming courses, renewal requirements and verify that you have completed any mandatory training and PVG / child protection requirements;

• respond to and communicate with members regarding your questions, comments, support needs or complaints, concerns or allegations in relation to hockey. We will use your personal information to investigate your complaint,

to suspend membership, take disciplinary action; and

• Where we process your personal information in pursuit of our legitimate interests, you have the right to object to us using your personal information for the above purposes. If you wish to object

to any of the above processing, please

<u>info@bambc.hockey</u>. If we agree and comply with your objection, this may

affect our ability to undertake the tasks above for the benefit of you as a member.

Option 2 – Volunteers' personal data:

We will need to collect personal information relating to criminal convictions or alleged commission of criminal offences where you are required to complete a PVG check under the **Protection of Vulnerable Groups** (Scotland) Act 2007. This information will include your PVG certificate number, PVG membership number, date of issue and any relevant information in relation to your membership of the PVG Scheme. If your PVG certificate is not clear, we will have a legitimate interest to collect references and any other applicable information to allow us to consider whether or not you can volunteer in a regulated role with children and/or vulnerable adults. Where we process your personal information in pursuit of our

legitimate interests, you have the

right to object to us using your

above purposes. If you wish to

object to any of the above processing, please contact us on info@bambc.hockey. If we comply with your objection, this may affect our ability to undertake the tasks above for the benefit of you as a volunteer.

Why we need your personal information – legal obligations

We are under a legal obligation to process certain personal information relating to our members, volunteers, participants, athletes for the purposes of complying with our obligations under:

- the affiliation to our National Governing Body Scottish Hockey to maintain a register of our members, which includes our members' name, address, the date they were admitted to membership and the date on which they ceased to be our member, and hold general meetings, including issuing notices and voting arrangements;
- the Protection of Vulnerable Groups (Scotland) Act 2007 to check that our coaches and volunteers are able to undertake regulated work with children and vulnerable adults;
 our sportscotland regulatory requirements to insert details of how personal data is processed to comply with these obligations;
- the Equality Act 2010, which requires us to process personal information to make reasonable adjustments where necessary; and

Other uses of your personal information

We may ask you if we can process your personal information for additional purposes. For example, with Partnerships with schools, local community and sports Hubs and Sports Councils. Where we do so, we will provide you with an additional privacy notice with information on how we will use

your information for these additional purposes.

Who we share your personal

information with

If your personal information is included in any images or videos taken by us at our competitions and events, we may share this with Scottish Hockey and Scottish Hockey North District for promotional and/or journalistic purposes.

We may be required to share personal information with statutory or regulatory authorities and organisations to comply with statutory obligations.

Such organisations include the Health& Safety Executive, Disclosure Scotland and Police Scotland for the purposes of safeguarding children and protection of vulnerable adults. We may also share personal information with our professional and legal advisors for the purposes of taking advice. BAMBC employs third party suppliers to provide services, including IT, Administration. These suppliers may process personal information on our behalf as "processors" and are subject to written contractual conditions to only process that personal information under our instructions and protect it. In the event that we do share personal information with external third parties, we will only share such personal information strictly required for the specific purposes and take reasonable steps to ensure that recipients shall only process the

disclosed personal information in

As an affiliated club of Scottish Hockey we are required to ensure that all of our members are members of Scottish Hockey as a condition of our affiliation. We will share contact details name, address, phone numbers and email address, date of birth, membership category with Scottish Hockey who will become a controller of your personal information when they receive it. Option 2 – Athletes' / Participants' personal data
We publish the results of our competitions on our website.
This includes competitors' First initial. surname and result.

How we protect your personal information

Your personal information is stored on our electronic filing system and our servers based in the [UK / EU], and is accessed by our volunteers for the purposes set out above. We are required to transfer your personal information outwith the purposes of games, training and events. Where your personal information is transferred outwith the EU, we will provide you with information regarding the safeguards that we have put in place with the recipient country to protect your personal

How long we keep your personal information

information.

Option 1 - *Members' personal data*We will only keep your personal

information for as long as

necessary to provide you with membership services.

Unless you ask us not to, we will review and possibly delete your personal information where you have not renewed your membership with us for 5 years. We will keep certain personal information of members for longer in order to confirm your identity, when you were a member of BAMBC and for how long.

We need to do this to comply with the Scottish Hockey transfer process, which requires us to keep a register of members or in the

event of a claim against BAMBC.

Option 2 – Athletes' personal data

We keep our athletes' personal information for 5 years. We have a data retention policy that sets out the periods for retaining and reviewing all information that we hold. This sets out different retention periods and you can request a copy by contacting us at info@bambc.hockey.

Your rights

You can exercise any of the following rights by writing to us at info@bambc.hockey.
Your rights in relation to your personal information are:

- you have a right to request access to the personal information that we hold about you by making a "subject access request";
- if you believe that any of your personal information is inaccurate or incomplete, you have a right to request that we correct or complete your personal information;
- you have a right to request that we restrict the processing of your personal information for specific purposes; and
- if you wish us to delete your personal information, you may request that we do so.
 Any requests received by BAMBC will be considered under

applicable data protection legislation. If you remain dissatisfied, you have a right to raise a complaint with the Information Commissioner's Office at www.ico.org.uk.

Where you are happy for us to do so, we would like to contact you by email with information about hockey, our latest news and upcoming events / competitions / courses. If you would like to receive email communications from us, please select from the following options below: information about hockey,

information about hockey, latest news, details of upcoming events. Once you submit your preferences to us, we will send you an email to confirm these. Please note that we will not email you with any information until you have confirmed your preferences by responding to our email. You may change your preferences at any time or request that we stop sending you email communications by contacting us at info@bambc.hockey. There is also an 'unsubscribe' button at the bottom of every email communication we send. (this may be from a third-party application namely TeamSnap)
